The saving, if any after meeting the recurring and non- recurring expenditure and contributions to development, depreciations and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
5. The school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
6. That the schools will no open classes under CBSE pattern particularly classes IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent / Manager of the school have individually gone through the provisions contained in the affiliation and examination byelaws and circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation and examination byelaws, directions issued by time to time and the law of the land.
8. That the school will ensure the compliance of all statutory requirements like EPF, ESI, and Labour Laws etc. with respect to school and staff of the school.
9. That the school will ensure that the Building Safety, Fire Safety and Water safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
10. That the school will ensure that all required infrastructure is available with the school before starting classes.
11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in the affiliation byelaws are available with the school before starting the classes.
12. That the school will follow the provisions related to fee contained in affiliation byelaws and will disclose the details of the fee to the students /parents every, year before start of session without resorting to any hidden charges in the heads of the fee.
13. That the school will not coerce any student / parent to buy books / stationary / uniform from any particular shop.
